

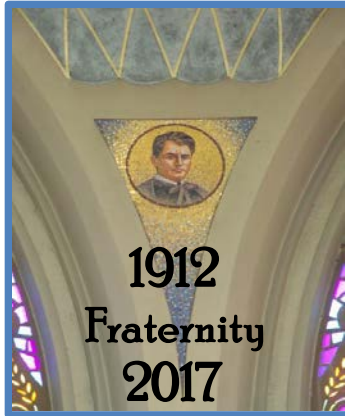

How do Annuities & IRAs from many other fraternal societies and life insurance companies compare to Providence Plans?

PROVIDENCE ASSOCIATION:

No Teaser Rates: Providence Plans are designed to offer a consistently favorable interest rate with a lifetime 3.00% guaranteed minimum rate.

No Renewal Terms: Once the member completes his surrender charge period, he or she will continue to receive a favorable interest rate with a 3.00% guaranteed minimum rate of interest.

OTHER FRATERNAL SOCIETIES AND LIFE INSURANCE COMPANIES:

Teaser Rates: Many other societies offer a favorable interest rate for only the first year or two and then subject the investor to a minimum rate as low as 1% - 2% for the rest of the surrender charge period.

Renewal Terms and Conditions: Other societies' plans can contain renewal terms and conditions that can result in the member committing to an unfavorable ongoing or minimum interest rate for an additional comparatively long surrender charge period.
